COACHING AGREEMENT

If approved as a coach by the Board of Directors of the Palm Beach County Youth Football League, Inc. (PBCYFL), I hereby acknowledge and agree to the following rules while participating in activities of the League.

_____ I will read and abide by the rules provided by PBCYFL.

_____ I agree as Head Coach that I am responsible for our team's MANDATORY League sponsorship, and to have turned in sponsorship to League Treasurer by game 5 of the Season. **Failure to obtain sponsorship shall result in Head Coach being suspended until sponsorship is obtained.**

_____ I understand that I am required to complete the USA Football Heads Up Certification Course. Team parents are only required to complete the NFHS Concussion Course, they can complete the Heads Up Course if they would like to.

_____ **I agree to comply with PBCYFL's "24 Hour Rule"- which simply states that coaches will not discuss a game or situation in a game until at least 24 hours after the fact.**

_____ I acknowledge that PBCYFL **DOES NOT allow Helmet to Helmet drills.** If found conducting helmet to helmet drills, coach will be suspended.

_____ **I agree to comply with PBCYFL's procedure regarding Lightning in the area, if I do not follow this procedure I understand that I will be suspended.**

_____ I understand that all registered athletes are required to have a parent or legal guardian present during all games and practices. Should I choose to transport a child to/from practices and/or games I do so at my own risk and liability. I understand that The Palm Beach County Youth Football League is not liable for any damages, injuries, etc. that may be sustained if a registered coach should choose to transport a child to games and/or practices.

_____ I will promote good sportsmanship at all times and I will conduct myself in a fair and ethical manner at all times.

_____ I agree to refrain from the use of alcoholic beverages/drugs immediately prior to, during and after League activities while in the proximate vicinity of League activities. I further understand that the League is an alcohol and drug free activity and my use of alcohol or drugs shall result in my removal as a coach in the PBCYFL.

_____ I understand that this is a youth sports program and acknowledge the importance of setting a good example for the children for which I have accepted responsibility. I agree to conduct myself in an appropriate manner while participating in League activities. **I will not use abusive or profane language.**

_____ I understand that fund raising is an important function of the League and I will fully participate in this activity and I will encourage my team to fully participate.

_____ I understand that coaches meetings are an important function of the League and I agree to attend all meetings when scheduled. I further agree to hold a minimum of three (3) parents(s) meetings for my team during the season.

_____ I acknowledge that I have read and understand the rules of the League pertaining to "all players must play a minimum of 6 plays per half" and I agree that I will follow this rule. I understand that I may be suspended from my coaching position for failure to follow this rule. Pee Wee division coaches agree to follow the specific rule for their division. Cheerleader coaches agree that all cheerleaders on their team will be encouraged to learn and participate in all cheers of the squad.

_____ I acknowledge that I have read and understand the "22 point" rule and I agree to follow the rule and conduct myself in the spirit of the rule. I further understand that I may be suspended from my coaching position for failure to follow this rule.
